Navigating the Music Industry's Evolving Landscape

Empowering Creators in a Time of Shifting Revenues

The global music industry continues to expand, with 2024 revenues hitting a record \$29.6 billion according to the IFPI Global Music Report 2025—marking the tenth straight year of growth. Streaming remains the powerhouse, accounting for over 69% of total revenue, with subscription streaming surpassing 50% of global revenues. Forecasts from Goldman Sachs suggest the market could nearly double to \$200 billion by 2035, fueled by emerging markets, new monetization models, and live events.

*Streaming revenues are at an all-time high,
but for creators, the reality tells another story.*



Yet, beneath this macro-level success lies a stark reality for many artists: perceived revenue drops and ongoing frustrations with per-stream payouts that often amount to fractions of a cent. Independent creators and mid-tier musicians report feeling the squeeze, with overall growth slowing to 4.8% in 2024 (down from prior years' higher rates) and artists capturing only a modest share despite billions in industry-wide earnings. Global surveys reveal widespread dissatisfaction: for instance, 76.7% of Thai users believe music

streaming services do not help artists increase revenue. Artists worldwide voice concerns over opaque algorithms, delayed royalties, and a system where platforms and labels capture the lion's share—leaving creators with inconsistent income.

XECHO is designed to address these pain points head-on, flipping the script with blockchain-powered tools that ensure fair, transparent, and immediate value capture for artists. By tokenizing tracks into Digital Ownership Tokens (DOTs), we enable true ownership, automated payouts, and direct fan engagement—mitigating the revenue disparities that plague traditional models.

The Industry's Mixed Signals: Growth vs. Artist Realities

While overall revenues climb, artist perceptions tell a different story. Spotify's 2025 Loud & Clear report highlights that nearly 1,500 artists earned at least \$1 million in royalties from Spotify alone in 2024, with independents capturing a growing slice. However, global surveys and artist testimonials reveal widespread dissatisfaction: per-stream rates have stagnated or declined in real terms, with many creators needing millions of plays to break even. In emerging markets like India and Brazil, where revenue growth is robust (India projected at 14.7% CAGR through 2026), local artists still grapple with low payouts and limited global reach.

This disconnect stems from centralized platforms prioritizing ad revenue and algorithmic control, often burying diverse voices. XECHO counters this by decentralizing the ecosystem on Binance Smart Chain (BSC):

- **Fairer Revenue Models:** Smart contracts trigger instant, programmable royalties based on actual streams—ensuring artists get a larger, predictable cut without quarterly delays or hidden fees.
- **Ownership Empowerment:** DOTs provide immutable proof of creation, allowing artists to license, trade, or fractionalize assets directly, turning music into a sustainable revenue stream beyond streaming.
- **Global Accessibility:** Borderless distribution and merit-based discovery amplify reach, helping artists in underserved regions tap into international audiences without gatekeepers.
- **Transparency at Core:** On-chain analytics eliminate disputes over play counts, giving creators verifiable data to optimize their careers.

XECHO is reshaping them to put artists first, ensuring that as the market grows, creators aren't left behind.

Artist Perspectives: Echoing Global Frustrations and Hopes

Our expanding network—now over 600 artists strong—mirrors the industry's broader sentiments. Creators from Europe to Asia share stories of revenue erosion: "Streaming pays pennies, and algorithms bury my work," says a Berlin-based electronic producer. A folk artist from Mexico adds, "Global growth is great, but without fair splits, it's meaningless for independents."

Key themes emerging from recent interactions:

- **Revenue Volatility:** Artists demand stability amid slowing growth and declining per-stream value.
- **Equity in Earnings:** Calls for better per-stream value and direct monetization paths, where music publishers receive only 4.5% and authors 10.5% of the streaming pie.
- **Discovery Barriers:** Frustration with pay-to-play playlists; desire for authentic, community-driven exposure.

XECHO responds by fostering a platform where these voices drive change—offering tools that convert global industry growth into tangible artist gains.
